RESOLUTION of the Scientific Director of the Centro de Investigación Biomédica en Red de Diabetes y Enfermedades Metabólicas Asociadas (CIBERDEM), in which it resolves the first call of the DIATRAIN (COMP) program, consisting in the award of three fellowships of one year of duration each for the stay in a foreign research institution aimed at postdoctoral researchers of the CIBERDEM consortium.

The DIATRAIN (DIAbetes Trans-national Research Advancement for Investigators) mobility program, co-financed by the FP7 Marie Curie Actions-People-2010-COFUND program of the European Commission with the Grant Agreement No. 267248, announced a call for applications for a mobility fellowship addressed to all the postdoctoral researchers of the CIBERDEM who wanted to carry out a stay in a foreign research institution between six and twelve months.

Considering the evaluations of all the candidates by the External Evaluation Committee and the Coordinator of the program, **The Scientific Director of the CIBERDEM**

RESOLVED, that a DIATRAIN (COMP) fellowship is awarded, in accordance with the terms and conditions found on the abovementioned Grant Agreement, to Dr. Mercedes Miranda, Dr. Sandra Rebuffat and Dr. Marta Montori for a research stay in the research groups of Symeon Siniossoglou of the University of Cambridge (UK), of Anne-Dominique Lajoix of the CPID in Montpellier (France) and of Solange Desagher of IGMM in Montpellier (France) respectively.

RESOLVED, that the duration of the fellowships is between six and twelve months and the starting date will be decided in agreement between CIBERDEM, the supervisors in the host institutions and the fellows.

RESOLVED, that this resolution will be publicly available on the website of the DIATRAIN program.

RESOLUTION of the Scientific Director of the Centro de Investigación Biomédica en Red de Diabetes y Enfermedades Metabólicas Asociadas (CIBERDEM), by which it is modified the resolution of the first call of the DIATRAIN (COMP) program, with date 19th December 2011.

The DIATRAIN (DIAbetes Trans-national Research Advancement for Investigators) mobility program, co-financed by the FP7 Marie Curie Actions-People-2010-COFUND program of the European Commission with the Grant Agreement No. 267248, granted on 19th December 2011 a COMP mobility fellowship to Dr. Mercedes Miranda, researcher of CIBERDEM.

Dr. Miranda has informed CIBERDEM she has been awarded a Miguel Servet fellowship from the Instituto de Salud Carlos III and hence resigns from her DIATRAIN fellowship due to incompatibilities before it has started.

Following the selection procedure, the empty position should be covered by the next person on the Reserve list, Sara Garcia, but after a revision of the eligibility rules, Sara Garcia has been found not eligible for this fellowship.

Taking into account the empty position left from the first call of the DIATRAIN COMP fellowship, **The Scientific Director of the CIBERDEM**

RESOLVED, to open an extraordinary call for the DIATRAIN COMP program, in order to cover the fellowship which remained vacant in the previous call.

RESOLVED, that this resolution will be publicly available on the website of the DIATRAIN program.
